The **VILLAGE OF ROCKTON, ILLINOIS**, has accused you of violating an ordinance of the Village. The maximum fine for this violation is \$750.00. If you pay the amount listed on the front of this citation at the **ROCKTON POLICE DEPT, 110 East Main Street, Rockton, Illinois 61072**, during the normal business hours or by mail and said amount is received within twenty (20) days of the date listed on the citation, this will constitute a guilty plea to the citation and you will **NOT** need to appear in court. If you sign the demand for hearing and plea of not guilty below and return it to the Village within the twenty (20) days period, the Village will arrange for a hearing date in the Circuit Court for the 17<sup>th</sup> Judicial Circuit, Winnebago County, Illinois and will provide you with a notice of the time and date. At that hearing, you may request a trial before the Circuit Court and contest the citation. **IF** you are found guilty at trial, the Judge may impose a higher or lower fine than listed herein. **IF you do not notify the Village** of your intention within twenty (20) days, we will assume you plead not guilty and you will receive a notice of a court appearance.
